I further agree to submit to any physical tests, which be necessary to complete drug testing. Should I fail to pass drug tests I agree to forfeit any trophy or award which I otherwise have won. I understand & agree that if I fail to pass the drug tests, my name will appear on a published list of suspended members if it is determined the drug test, I agree to waive any claim for which legal relief is available.

I agree to pay any attorney fee & litigation expenses incurred by any person, real or corporate, whom I may sue in an effort to challenge this Release From Liability form.
